This mostly defeats the point, since without the bus lane this is mostly just a regular bus on build a viaduct to accommodate the buses, then I think the project should be rerouted to Commerce St, which does have room for dedicated bus lanes and which has similar population and business density to Houston. Since the link to the Frost Bank Center is a requirement, it can be reached by hooking north at the end of the line on Coca-Cola place, which also takes the buses straight to the front steps of the Freeman Coliseum. Additionally, this route would serve St. Philips college, which Houston St. routing does not. The current bus on Commerce St., the 25, has higher ridership than the Houston bus (24), so this route would probably have higher ridership too. Third, the roll plots seem to pretend that the railroad crossing at St. Paul's square doesn't exist. It does, and will be a substantial delay for the bus. I still believe the route should cross I-37 at Montana street, which is already bus-only here in at least one direction, use the existing Robert Thompson transit center, which is both cheaper (because it already exists) and higher quality than any stop you can build on the side of the street on Commerce, and rejoin the planned route on Cherry St. or some point east (which also reduces the sharpness of the turn compared to the intersection at Commerce St). If my recommendation of rerouting to Commerce street east of Cherry is also taken, then it would make sense to continue on Montana for a few blocks first, where the two streets are closer. Montana goes under the railroad, so it bypasses the railroad crossing, significantly improving the speed and reliability of the bus. Fourth, the connection to Centro Plaza is still bad. Even if the bus route cannot be designed to ac	Thank you for your comments. Currently there are plans for three VIA Rapid stations east of Pine St. These stations are proposed at the following intersections: New Braunfels/Houston, Walters St./Houston, Mel Waiters/Houston, and at the Frost Bank Center. The buses on this segment of the corridor will run in mixed traffic. Regarding your comment on the railroad crossing at St. Paul, the planning team is aware that the route alignment crosses the railroad track at grade and is subject to interruptions by railroad operations. Opportunities to minimize delays along the corridor will be evaluated. The route selection was part of an overall planning process in 2016-2018 for the Advanced Rapid Transit program, which included public engagement, ridership modeling, and economic development opportunities, to determine the corridor. Regarding your comment on transfers to and from Centro Plaza, pedestrian improvements are being considered Regarding speed and convenience, VIA's ART system, called VIA Rapid, is designed to deliver fast, frequent and reliable public transit, using bus-friendly traffic signals, and offering off-board fare collection for faster boarding. Transit signal priority (TSP) on the Silver Line will work similarly to TSP on Fredericksburg Road, and Zarzamora Streets for Primo. TSP is activated when the bus is running later than the scheduled time. When activated, TSP extends the green signal or truncates the red light on the cross street. The VIA Rapid project allows for flexible design of stations and bus improvements to accommodate roadway characteristics throughout the corridor.
